## Physicians

**AAFP** : The AAFP has reviewed Authentic Women’s Health: Advancing Access Across the Lifespan (Activity #104280) and deemed it acceptable for up to **5.0 Live AAFP Prescribed credits**. Term of Approval is from 04/19/2024 to 04/20/2024. Physicians should claim only the credit commensurate with the extent of their participation in the activity.

**AMA PRA Category 1 Credits™** : AAFP Prescribed credit is accepted by the American Medical Association as equivalent to *AMA PRA Category 1 Credit™* toward the AMA Physician’s Recognition Award. When applying for the AMA PRA, up to 10.75 Prescribed credit may be reported.

**AOA** : CME activities approved for AAFP credit are recognized by the AOA as equivalent to AOA Category 2 credit.

- Self-paced (enduring) credit is reported as Category 2-B
